### **CHAIR'S MESSAGE:** A Spotlight on Educators and Advocates



Addiction medicine as a field demands a lot from each of us. No longer is it sufficient to be just the capable diagnostician, pharmacologist, and avid reader of journals. Now, many of us find ourselves educators and advocates, facing questions we barely anticipated. How do we educate our patients on the risks of a substance when state laws and elaborate marketing campaigns tell them otherwise? How do we motivate our overworked colleagues to under-

take the treatment of addictions, and help with the destigmatization of the disease?

We face an even greater challenge with the inordinate number of patients who have limited access to care due to poverty, geography, poor public health policy, a deteriorating safety net, and persistent stigma. How do we engage with patients who face so many obstacles? How do we preserve ourselves while we do this important work?

For many of us, CSAM conferences offer a salve by way of time spent with like-minded colleagues addressing these core questions. This year, we continue the tradition by providing a review of addiction fundamentals, but with a twist: we have asked each presenter to comment on strategies for education and advocacy in their areas of expertise. Robert Lustig, MD, author of "The Hacking of the American Mind," will discuss his work on technology and addiction. Fay Zenoff, MBA, director of the Center for Open Recovery, will discuss the role personal recovery can play in our work. We will show the documentary "The Providers," and chat with the filmmaker and a physician featured in the film about battling the opioid crisis in rural New Mexico. A comedian in recovery will perform at our dessert reception and share her own journey to advocacy.

At the time of this writing, our planners are putting the finishing touches to the board exam preparation track, mutual help meetings, case discussions, and pre-conference workshops. Their dedication to crafting a comprehensive conference, featuring diverse and memorable speakers, makes me optimistic about our field. The questions we face are big, but so is the tent we are building.

The Board Exam Preparation Track takes place over a span of four days during the conference. It is designed for those preparing to take the American Board of Preventive Medicine (ABPM) Addiction Medicine Board Exam. The Wednesday workshop and daily morning sessions cover 16 key topics, with sample exam questions and rationale provided for answers, as well as test-taking and study tips.
