## Loan repayment programs

PHC is committed to providing resources for our community and provider network that will help ensure the health of our members and access to care across our provider network. This page contains information about various loan repayment programs that may be available to providers across our network.

## **Loan Repayment Programs Overview:**

Providers may qualify for different types of loan forgiveness programs, typically made available by the federal government to help offset the debt of medical education loans when they start practice. Forgiveness programs can be an excellent way for candidates to receive debt relief while hiring organizations may increase recruitment and retention efforts for providers awarded, while also informing hiring organizations to better support candidates in need of relief while employing best practices.

#### Information for Provider candidates:

Are you a provider candidate that would like to hear more about opportunities to reduce debt from graduate medical education loans? If so, Northern California may have opportunities for you to practice and receive much needed debt relief. Depending on the practice type and patient population served, there may be several loan repayment opportunities available if you choose to practice in an outpatient primary care setting. While each program is different, most loan repayment program opportunities are available based on a designation called a medically underserved area.
