Lowering Overuse of Cesarean Sections

Partnership HealthPlan of California (PHC) is dedicated to quality healthcare for mothers and babies. Studies have found that Cesarean sections (C-sections) are associated with higher rates of maternal complications and longer recovery times, higher rates of NICU admissions, and increased barriers to the mother-infant breastfeeding relationship. One of the key contributors is elective induction of labor in low-risk, first-time mothers¹. Another is a hospital policy of not having labor and delivery set up to offer the option of a trial of labor after cesarean section (TOLAC). In Southern California, some obstetricians offer elective primary cesarean section, but this has not been found to be a contributor in the PHC region.

One way to help reduce C-sections is through educating mothers about the potential health outcomes associated with C-sections including its effects on future births. The CMQCC site includes links to "A Toolkit to Support Vaginal Births and Reduce Primary Cesareans", "The Implementation Guide" and a "Slide Set for Professional Education", as well as information about the My Birth Matters Campaign that the CMQCC partnered on with the California Health Care Foundation (CHCF) and Consumer Reports Sharing these educational opportunities with patients who are asking for elective cesarean section can support conversations with their prenatal provider, to make well-informed decisions for their health and the health of their babies.²

Through our Hospital QIP, PHC's goal is to support our hospitals by reducing avoidable C-sections. Measure 5 of the Hospital QIP directly correlates to this by awarding hospitals 10 full points for achieving the target of < 21.7% Nulliparous, Term, Singleton, Vertex (NTSV) Cesarean rate, or 5 partial points for achieving \geq 22.0% - 23.6% NTSV Cesarean rate. What Is a Safe Table Forum?

Safe Table Forums facilitate an open dialogue about patient safety and quality issues in a case study format. The forums are conducted by a federally-listed Patient Safety Organization with legal protection of content discussed protected under the Confidentiality and Privilege Protections of the Patient Safety Act. CHPSO members

voluntarily share actual patient safety case-scenarios with systematic concerns. Follow-up discussion offers group input on possible interventions, preventative measures or system changes.

At the conclusion of the Safe Table meeting, participants will be able to:

- Describe information about best practices relative to patient safety
- Discuss challenges in a frank, open discussion with other hospitals
- Describe lessons learned from other organizations as it could relate to the work in the participant's hospital
