



Funding Opportunities: *CalAIM Enhanced Care Management and Community Supports*

Updated December 30, 2024

Various funding opportunities are available to Partnership HealthPlan of California's CalAIM Enhanced Care Management (ECM) and Community Supports (CS) network providers. This document aims to create a summary of those opportunities and where to find more information to support our internal staff in providing pertinent information to our CalAIM providers.

There are two types of funding, those that are facilitated by Partnership and those that are facilitated by the Department of Health Care Services (DHCS). Please note that for DHCS-led opportunities, DHCS is the subject matter expert and often makes updates to their website, so it is strongly advised to encourage providers to check there for the most up-to-date information.



Partnership-Facilitated

Partnership CalAIM Grant: Grant funds intended to invest in ECM and CS provider capacity and delivery system infrastructure to support the launch of these important programs. Providers submitted applications indicating what they needed funds for, how much they needed, and milestones indicating they had reached their goal.

CalAIM Quality Improvement Program (QIP): Embedded in the existing QIP, dollars were allocated to incentivize providers to submit reporting timely and accurately. It is likely that future QIP dollars will aim to incentivize improvement in quality measures tied to ECM efforts.

DHCS-Facilitated

PATH Capacity and Infrastructure Transition, Expansion and Development (CITED):** DHCS has engaged with a third-party administrator to oversee the application process for PATH CITED funding. It provides funding to enable the transition, expansion, and development of ECM and CS capacity and infrastructure. ****CITED Round 4 funding will open January 6, 2025. Applications are due March 7, 2025.**

Justice-Involved Capacity Building Program: Provides funding to correctional agencies, correctional institutions, and county social service departments to support the implementation of pre-release Medi-Cal application and suspension processes. DHCS launched this in two rounds. Round 1 was a planning grant and Round 2 was an implementation grant. PATH Technical Assistance/TA Marketplace: Provides funding for providers, community-based organizations, counties, and others to obtain technical assistance resources to establish the infrastructure needed to implement ECM and CS. PATH Collaborative Planning Implementation/Learning Collaboratives: DHCS has engaged with a third-party administrator to oversee the administration and management of the program. This administrator selected facilitators to lead groups of stakeholders in a county or region. The goal of these groups is to work together to share best practices and identify/resolve issues. Partnership Regional Directors are responsible for representing Partnership in the region(s) they oversee so Partnership can support issue resolution as appropriate.
