Targeted Rate Increase Policy

The Department of Health Care Services (DHCS), which operates the Medi-Cal program, has finalized the calendar year (CY) 2024 Managed Care Organization Provider Tax Targeted Rate Increase (TRI) policy. This policy establishes a reimbursement floor for a subset of providers and Medi-Cal procedure codes. Full details can be found on the DHCS website.

Mandatory Enrollment for Foster Youth in Single-Plan Counties in 2025

Effective January 1, 2025, the Department of Health Care Services (DHCS) will mandatorily enroll Foster Youth and Former Foster Youth Medi-Cal members living specifically in single-plan counties (i.e., Alameda, Contra Costa, and Imperial) to transition from Medi-Cal FFS to enroll as members in an MCP.

As of January 1, 2024, the Department of Health Care Services (DHCS) required all managed care plans to ensure network providers complete Early and Periodic Screening, Diagnostic and Treatment (EPSDT) specific training no less than every two years.
