


Measurement Year 2023 (MY2023) / Reporting Year 2024 (RY2024)

- HEDIS[®] Hybrid Measure: Data collected from both Administrative sources (claims, lab data, etc.) and abstracted from patient medical charts (paper and EMR).
- <u>Health Plan Accreditation (HPA) Measure</u>: Uses HEDIS data to effectively measure the Health Plan's care and service performance, which determines the Health Plan's Star Rating.
- <u>Medi-Cal Managed Care Accountability Set (MCAS)</u>: Uses HEDIS data to effectively measure the Health Plan's care and service performance.

The following measures are applicable to both HPA and MCAS Reporting *unless otherwise noted.
