
#### Important Program Reminders and Updates:

- MY2024 CG-CAHPS results were emailed out to qualifying providers on Friday, November 8, 2024. For providers who did not qualify for CG-CAHPS, Survey Option part 2 is due by January 31, 2025.
- 2024 Quarter 3 Blood Lead Screening Reports were sent out via secure email on October 4, 2024. If you need a copy of these reports, please reach out to the QIP team.

eReports	Twice a week	Tuesdays & Thursdays	Update occurs during business hours. The QIP team recommends uploading before 5pm or use Monday and Wednesday as upload days.
PQD	Monthly	10th of the month	Prior month data displayed.
Preventive Care Dashboard	Daily	Monday - Friday	Supplemental reports. These reports are to be used in conjunction with eReports CIS10, IMA, W15 & WCV measure reports. They do not contain supplemental data such as upload and they do not apply the 14-day for CIS10 & W15.
